Location

The property is located to the eastern fringes of Renishaw, a village situated between the towns of Eckington and Barlborough within the jurisdiction of North East Derbyshire.

The property is ideally situated off Sheffield Road, an arterial route providing direct access to Junction 30 of the M1 motorway to the east and providing access to Sheffield some 10 miles to the north west.

Description

The available property comprises an industrial warehouse providing two self-contained workshop units, on a surfaced site extending to 0.85 acres in total. The property is currently fully occupied and income producing.

The building is of frame construction with clad elevations incorporating four large loading doors, beneath a pitched covered roof incorporating translucent light panels.

Internally, the building has been split to provide two units being occupied as a MOT workshop and a storage warehouse / repair shop respectively. The rear of the site comprises a secure gated compound suitable for open storage.
