Location



Darlington is a popular market town both with commuters and businesses. The premises are located a 5 minute walk from the railway station and just off the A167 inner ring road which provides access to the A66 to the south and the A1(M) to the north.

It lies adjacent to a 650 space multi storey car-park and within a few hundred yards of the £30m Feethams Leisure Hub which was opened in 2016 and features a 9 screen multiplex Vue Cinema, an 80 bedroom Premier Inn and various national and independent bars and restaurants including Nandos and Hungry Horse.

Description

A two storey building of brick construction under a flat roof including a three bedroom manager's flat at first floor level that is separately accessed from Beaumont Street.

The ground floor comprises a main bar area divided into two sections and the upper floor offers a function room with bar.

The building is centrally positioned and offers scope for alternative uses including leisure and food subject to planning and other necessary consents.
