Abergele is a town located on the North Wales coast approximately 34 miles north-west of Chester and a similar distance east of Bangor. The town is served by the A55 North Wales Expressway; the principal arterial route through North Wales.

The property is situated within a semi-rural location off St George Road approximately 0.5 miles south of Abergele town centre and benefits from easy access to the town centre and the A55.

### **Description**

The residential property comprises а gated development site which contains a detached 'gate house' completed to a good standard and a detached three storey period building known as 'Gainsborough House' which is in the process of being converted into 6no. apartments together with a substantial site which benefits from planning permission for the development of up to 47no. residential dwellings.
