Location



The site is located to the east side of Byng Road directly opposite Kingfisher Drive and on the fringe of the village of Hipswell adjoining the neighbouring community of Colburn.

It has good access to public transport via bus and is within walking distance of shops and services within Catterick Garrison and Hipswell Primary School. It is also in close proximity to the £25 million new Princes Gate Shopping and Leisure Complex including two restaurants, a 60 bed Premier Inn and a 7 screen Empire Cinema which lies adjacent to an existing Tesco Superstore and Leisure Centre.

It is approximately 3.6 km (2.25 miles) from the new junction with the soon to be upgraded A1(M) at Catterick.

Description

An irregular shaped site with the proposed built area being relatively level but with steep banked wooded slopes to its southern boundary, the initial management of which is proposed to be retained by the current owners. It lies in an attractive secluded position alongside the tree-lined Colburn Beck.

Outline planning permission for 11 dwellings (ref: 15/00935/OUT) was granted by Richmondshire District Council on 1st March 2016 and a Decision Notice is due to be issued subject to a draft \$106 Agreement which will seek (subject to Economic Viability Assessment) a 40% Affordable Housing provision and a contribution towards education and a nearby play area.
